5. The slipway at The Club is used for a variety of sports and purposes; it is your responsibility to operate the area with care and consideration to other users and in a safe manner.
6. Access to any other facility other than the Water Sports Complex changing rooms, Slipway Bar, Slipway and surrounding area requires prior approval from a Duty Manager.
7. Any damage or faults to/with the equipment should be reported to The Club immediately.

I understand and accept that watersports involve inherent risks that can result in physical injury, loss and/or death. I accept in full that The Club accepts no responsibility for injury or loss of any kind, including to the full extent permissible by law, losses arising from physical injury and/or death sustained on The Club property or whilst engaged in any activity following launching a vessel from The Club premises to myself. I waive any right to such claim, however arising, against The Club, its employees, Members, servants or agents. I also agree as a condition of accessing The Club that I indemnify and hold harmless The Club, its employees, servants or agents, against all such claims brought by third parties however arising as a result of my use of the facilities at The Club whether negligent or not.

I accept full responsibility for any damage I may cause whether accidental or with intent. I take responsibility if the equipment is stolen or damaged whilst being used under my supervision with full acceptance that I will be responsible to cover the costs to repair or replace said equipment.

I also acknowledge that I have been advised by The Club that I am recommended to wear a life jacket at all times whilst in, on or around the water.
